We are requesting quotations for the;

1. The design of a Themed Wahooz Restaurant Parkside Food Service and Seating Area
 - i. Themed Restaurant Service Counter
 - ii. Themed Public Seating and Access Space
- b. The design of the Restaurant Service Counters and the Seating Areas must take into consideration the coastal environment and conditions experienced at uShaka Marine World in particular;
 - i. Wind Strengths and Directions – consider side panels to protect guests from prevailing winds
 - ii. Rain Direction and Volume - consider side panels to protect guests from prevailing winds
 - iii. Harsh Direct Sun Shine Environment
 - iv. Salt Spray and Corrosion caused by exposure to these coastal conditions
- c. The design brief will be provided at a compulsory site visit, date below
